



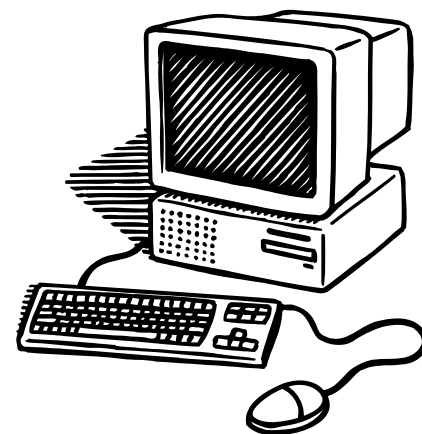
# LaserPro<sup>®</sup> Integrated Disclosure Review
