**David Boneno** has served as general counsel to the Louisiana Bankers Association since 1998 where he is responsible for advising LBA member banks, savings banks and savings & loan associations on banking law and regulatory issues, representing the industry in the state and federal legislative process, and representing the interests of the banking industry in the judicial system by filing amicus curiae briefs in selected litigation. David earned his Bachelor of Science in Finance from Louisiana State University and his Juris Doctorate from Tulane University School of Law. He serves on the Louisiana State Law Institute’s UCC Committee, Security Devices Committee, and Component Parts Property Committee, and he also regularly teaches seminars on Mortgage Loan Documentation. He is a member of the Louisiana Bar Association. He also serves as an assistant bar examiner for Code III.

**Joe Gendron** joined the LBA staff in 2007 after spending three years as staff attorney for the House Committee on Commerce of the Louisiana House of Representatives. His primary responsibilities are representing the interests of LBA member banks at the state legislature and with the Louisiana congressional delegation, and organizing the grassroots efforts of the LBA on issues of importance to Louisiana bankers. Joe received his Bachelor’s of Science in Accounting from Louisiana State University and his Juris Doctorate and a Bachelor’s of Science in Civil Law from LSU’s Paul M. Hebert Law Center. He is a member of the Louisiana Bar Association and served as a state district court law clerk to the Honorable Brenda Bedsole Ricks in the 21st Judicial District Court.
